Any vendor not Checked by 8:00 am on October 24, 2026, shall forfeit all fees paid and will lose assigned space.

- All payments must be submitted by Check, Venmo, Cash or Credit/Debit Card to Whole Vine Inc. If your non-refundable fee of \$50.00 is not received by Application Due Date (September 7, 2026), a Vendor Space will NOT be guaranteed. **This is a rain or shine event. Come prepared.**
- Any application that is incomplete will not be eligible for selection. Please completely fill out this application in its entirety.
- CANCELLATIONS must be in writing and received by Whole Vine Festival no later than September 30, 2026.
- Event Date & Time: October 24, 2026, 10:00 am – 5:00 pm.
- Vendors must submit a completed vendor/exhibitor application, full payment by September 7, 2026. Vendors who are required to get a Health Department Permit must obtain one and Temporary Business Licenses or permits needed and provide a copy.
- Vendors set up the preceding Friday, October 23, 12:00 pm to 4:30 pm and Saturday, October 24, 7:00 am. All vendors must be set up no later than 9:30 am on Saturday.
- **NO VENDOR IS ALLOWED TO TEAR DOWN OR TAKE PRODUCT OUT EARLY.** This negatively affects the festival vibe.
- The Whole Vine Festival reserves the right to refuse space to any vendor for any reason other than race, creed, national origin, sex, physical handicap, or any other reason by law.
- All Vendors assume all risk of any loss, injury, or damages. The Vendor, by signing this contract, assumes all risks and agrees to all stated terms and conditions of this contract and holds The Whole Vine Festival not responsible for any claims such as loss, damage, or injuries. Overnight Security is provided.
- The Vendor will not display, promote, possess, or sell any product or merchandise that violates any Federal, State or Local laws and ordinances regarding the sales of specialty items, trademarked logos, instruments, or weapons including knives.
